- This grant will stipend 25-30 postdoctoral fellows each year of \$70k per year.
- This support is aimed for fellows to conduct basic cancer and human disease-related research in laboratories in North America, Europe, Japan, and Australia.

- The awardee will receive \$600k over three years. In addition, the foundation will retire up to \$100k of any medical school debt still owed by the awardee.
- The program equips young physicians with the resources and training to become successful clinical investigators, aiming to increase those who can transition smoothly between lab and bedside for breakthrough treatments.

- Define priorities for funding every two years to stimulate research in understudied areas. Six categories to choose from.
- 2024-2026 research grant priority programs: Ethnic & racial diversity, Understudied populations with elevated suicide rates, survivors of suicide loss.

- Applicants must have a doctorate or published work of doctoral character and quality.
- The program is designed to help meet the costs of travel to libraries and archives for research purposes; the purchase of microfilm, photocopies, or equivalent research materials; the costs associated with fieldwork; or laboratory research expenses

Marine

- No deadlines. Proposals for grants up to \$20,000 will be reviewed on a monthly rolling basis.

- Funds ranges up to \$200,000.
- The foundation encourages one-year proposals, with the goal of fostering the capabilities of new cancer researchers or new cancer approaches by established cancer researchers.

- Deadline: September 16, 2024
- \$650,000 over three years
- The grant requires that research institutions shift their policies and practices to value collaborative research.

- \$15,000 - \$25,000
